Philip Law, British Plastics Federation

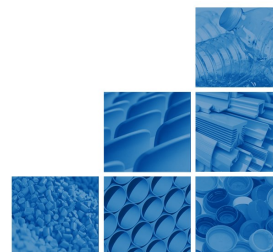
